The Select Board discussed it and agreed to her becoming the town's new ACO officer starting September 1, 2023.

Robert Hogg- Rob brought Tom Bolen and Lance Stewart from the Transmission line committee in Albion to the meeting to explain what they have learned about the LSP Power Grid Maine LLC and the powerline proposed plan that will be going through certain property belonging to both residents and the town as well. Tom recommended for the town to form a committee and to be vocal about not wanting this. There is a plan for a rally at the Blaine House on September 9, 2023 @ 9:00am if enough people show interest. After a lengthy discussion the Select Board asked Rob to set up a meeting between LSI Power, the Select Board and the Trustee to the Forestry Area. Rob agreed to try to set up a meeting.
