C. Guests: Jennifer Wixson and Steven Farr attended the Select Board meeting to discuss the Budget Committee and appointing the committee members. Jenn informed the Select Board Jennifer Wixson, Joyce Benson, Nancy Clifford, Steve Farr and Josh Bean will like to be appointed as members of the Budget Committee. The Select Board approved (motion: Selectperson, Brian Blake, 2nd: Selectperson, Thomas Byron, Vote: Unanimous). Jenn also discussed with the Select Board about if someone else has an interest in Budget Committee could they also be appointed. The Select Board stated if anyone else is interested they should be put on the Select Board agenda anytime (before November 1) to be appointed. Steven Farr commented that he would not like to be doing the Budget Committee (He is very busy and doesn't have the time) unless they need him as a member. Jenn informed the Select Board that she would like to do the budget meeting with the Select Board budget meeting. The Select Board agreed with the idea.

D. Old Business:

1. Plow Bid form/ Ad- *STTS* Aimee Nelson informed the Select Board she has posted it and put it on the town website and in the Rolling Thunder.
2. Copier Contract- The lease for the copier in the town office has expired. The Select Board reviewed the contract for a new copier (same brand and functions, print more pages at faster). The lease was done with a different company and the Copier Contract will decrease by \$7.56 a year

1. General Assistance Hearing- The Select Board decided to have the General Assistance hearing on Wednesday, October 15, 2025 @ 6:00pm. *STTS* Aimee Nelson will post about the hearing.
2. 2023 Property Maturity Letters- 19 property owners owe 2023 property taxes. Certified letters will be going out on Friday, September 26, 2025 to notify the property owner they have until November 10, 2025 @ 4:00pm to pay the 2023 tax bill or the town forecloses on their property.
3. Preliminary 2026 State Valuation- The Select Board reviewed the paperwork.
4. Rabies Clinic- The Select Board approved *STTS* Aimee Nelson setting up a rabies clinic in January 2026 @ the town office.

The Select Board also stated that posting the roads depends on the weather.
