D. Old Business:

1. Tax acquired properties- A new law went into effect last year that states any tax acquired property sales the town has to give all extra funds back to the previous property owner. The previous property owner has passed away and nothing has been done probate wise. MMA recommends that the town put the finds into an account and hold onto them for the foreseeable future until a plan is set. *STTS* Aimee Nelson asked the Select Board if she can open another account at Bangor Savings and put the funds in it. The Select Board voted, Motion- Thomas Byron, 2nd- Brian Piper, and approved the request.
2. Junk Yard Permit date- The Select Board decided on Wednesday December 6, 2023 @ 6:00pm for the Junk Yard Permit. *STTS* Aimee Nelson has posted and sent out all the notifications.
3. Town dates- The Select Board discussed it and decided on March 16, 2024 for the Town Meeting. *STTS* Aimee Nelson will do the paperwork to have the meeting at Troy School, after the school approves the date Aimee will post the date.
4. Bolster's Rubbish Removal- Bolster's approved the no fuel surcharge and emailed the contract. Selectperson, Thomas Byron signed the contract.
5. Trash Stickers- *STTS* Aimee Nelson contacted Trash Sticker, Inc (the company Thorndike uses) and received a quote of \$909.00 (\$135.00 of the quote is a onetime fee for the new art plate, designing the stickers) for 15,000 trash stickers (\$2,785.00 was price from the other company last year) The Select Board reviewed the quote and the options for the color of the sticker. The plan is for the color to stay the same. Aimee will contact the company and get a design made up and bring it to the next Select Board meeting for approval.
